## NATION BUILDING TAX (NBT)

### Furnishing of Returns

For the quarter ended 30.06.2011, every person or partnership who or which liable to pay Nation Building Tax.

- being a person or partnership engaged in the manufacture of any article or provision of any service, is required to furnish the Nation Building Tax return to the Nation Building Tax Branch located in the 12<sup>th</sup> floor of the Inland Revenue Building; and
- being a person or partnership engaged in the wholesale or retail sale, is required to furnish the Nation Building Tax return to the respective Regional Office within the limits of which the business is located.
